CHARTER OAKS COMMUNITY ORGANIZATION (COCO) POOL RULES AND REGULATIONS

The pool is for COCO Pool Members and their Guests. The number of persons (household and guest group) Pool Members may bring onto the pool grounds per day is ten. Pool Members need to inform their Guests of the pool rules and advise them that they are swimming at their own risk. Pool Members further need to ensure that all guest fees are paid. Charter Oaks residents who are not pool members may not be guests; however, they may participate in specific pool programs or functions that have been approved by the COCO Board. (Example: fundraisers, swimming lessons, neighborhood holiday parties). **ALL** pool users shall comply with the following pool rules:

POOL AND POOL GROUNDS:

- 1. Pool Members and their guests are permitted on the premises **ONLY** during the hours from 6 a.m. to 10 p.m. Pool Members are not allowed to provide their pool key to **ANYONE** not a member of their permanent household.
- 2. The pool gate **MUST** be kept closed and locked at all times. Remember to bring your key.
- 3. Children 7 years and younger must be supervised by an adult, even if a lifeguard is present. For your safety, do not swim alone—use the "Buddy System."
- 4. Children using the baby pool must be monitored at **ALL TIMES** by the adult responsible for their care.
- 5. Children who are not potty trained must wear swim diapers.
- 6. It is the responsibility of the parent or guardian of any child under age 18 to verify that a Lifeguard is on duty before allowing that child access to the pool without the parent's or guardian's supervision.
- 7. NO UNDERAGE ALCOHOL CONSUMPTION IS ALLOWED.
- 8. **USE OF TOBACCO PRODUCTS IS NOT ALLOWED** anywhere on the pool grounds, by the bar-b-que pit, in the parking lot, in the clubhouse, or in the bathrooms.
- 9. NO GLASS CONTAINERS ARE PERMITTED ON POOL GROUNDS.
- 10. No one is allowed in the clubhouse **EXCEPT** for the Lifeguard, a Clubhouse renter (and members of the renter's party) and persons authorized by COCO to perform specific maintenance and services.
- 11. COCO may limit the number of guests and/or deny use of the pool and pool grounds to those who may, in the Rental Manager's judgment, abuse the facility or endanger the safety of others, or any violation of these rules.

- 12. No running, pushing, horseplay or unsafe conduct in the pool or on the pool grounds.
- 13. Please do not bring food, toys, or other objects into the pool that may foul the water or cause damage to the filtration system.
- 14. **PLEASE WATCH YOUR LANGUAGE** Do not use vulgar or abusive language.
- 15. Appropriate swim attire is required at all times—no nude bathing, underwear, or cut-offs in the water.
- 16. The diving board may be closed at the discretion of the lifeguard. **ONLY ONE PERSON WEIGHING LESS THAN 200 POUNDS IS ALLOWED ON THE DIVING BOARD AT A TIME**. Divers shall make sure that the area under the diving board and around the diving area are clear before diving or jumping off the diving board.
- 17. ALL PERSONS USING THE POOL GROUNDS ARE RESPONSIBLE TO PICK UP THEIR OWN TRASH AND DISPOSE OF IT PROPERLY.
- 18. NO PETS ARE ALLOWED ON THE POOL GROUNDS.
- 19. Charter Oaks Community Organization (COCO) Pool and Clubhouse are private property. As such, COCO excludes the following:
 - a. License holders from carrying concealed handguns on this property as provided in Section 30.06, Texas Penal Code.
 - b. License holders for carrying openly on this property as provided in Section 30.07, Texas Penal Code.

LIFEGUARDS ON DUTY:

- 1. When a Lifeguard is not on duty, **YOU SWIM AT YOUR OWN RISK**.
- 2. When the Lifeguard is on duty, he/she is the sole authority. His or her primary duty is to look out for your safety. **DO NOT DISTRACT LIFEGUARDS** from their job by visiting with them.
- 3. When a Lifeguard takes his or her 10 minute break, it is **ADULT SWIM ONLY.** No children are allowed in the pool during break regardless of adult supervision.
- 4. If a Lifeguard is on duty, report to him or her that you are a member and, if you have brought guests, how many guests you have brought **AND PLEASE PAY THE GUEST FEES TO THE LIFEGUARD**.

PLEASE DO YOUR PART TO KEEP YOUR POOL CLEAN, SAFE, AND FAMILY-FRIENDLY.
